No.FP-MSME-(OFPP-2016)-39/2018 7253/MSME, Bhubaneswar, dt. 13-11-2018

Subject: Amendment to Odisha Food Processing Policy (OFPP), 2016.

After careful consideration, Government have been pleased to amend the following provisions of OFPP-2016:

1. Under the para-7.1 (ii) of OFPP-2016, the existing provision shall be replaced with the following:

Para-7.1 (ii) "Enterprise set up by SC / ST / Women/ differently abled / Technical Degree / Diploma holding Entrepreneurs and also those set up by anyone in Industrially Backward Districts including KBK. For the enterprises set up by SC/ ST / differently abled/ Women / Technical (Degree or Diploma holders), their stake in equity participation shall be 51% or more individually or jointly."

2. Para-10.10 of OFPP-2016, stands deleted,

3. Under the Annexure-II- "List of Ineligible Enterprises/Industries" at **Sl. No. 05**, the existing provision shall be replaced with the following:

Sl. 05 Edible / Non-Edible vegetable Oil Mills having;

- (i) Expeller with investment in plant & machinery less than Rs.10 lakh.
- (ii) Solvent Extraction with investment in plant & machinery less than Rs.50 lakh.
- (iii) Hydrogenation of Oil.
- (iv) Repacking of oil with Filtering, Coloring and Deodorizing.
- (v) Refining of Oil with investment in plant & machinery less than Rs.5 crore.

4. Under the Annexure-II- "List of Ineligible Enterprises/Industries" at **Sl. No. 14**, the existing provision shall be replaced with the following:

Sl. 14 **"Pre-processing of oil seeds:
decorticating, parching and frying."**


5. Under the Annexure-II- "List of Ineligible Enterprises/Industries" at **Sl. No. 15**, the existing provision shall be replaced with the following:

Sl. 15 **"Standalone Packaged drinking/
Mineral water units, Aerated water, soft
drink (except the units manufacturing
fruit pulp and/or juice out of it)."**

6. The aforesaid amendments in the OFPP-2016 shall come into force with immediate effect.

ORDER: - Ordered that the Notification be published in an extraordinary issue of *Odisha Gazette* and copies of the Notification be forwarded to all Departments/ all Heads of Department.
