Subject: Amendment to Odisha Food Processing Policy (OFPP),2016.

After careful consideration, Government have been pleased to amend the following provisions of OFPP,2016 as follows:

1. Under the Annexure-II- 'List of Ineligible Enterprises / Industries' at **SL. 01,** the existing provision shall be replaced with the following:

## SL. 01. "Rice Hullers & Rice Mills".

2. Under the Annexure-II- 'List of Ineligible Enterprises / Industries' at **SL. 02,** the existing provision shall be replaced with the following:

## SL. 02. "Flour Mills (excluding Roller Flour Mills), Pulse Mills and Besan Mills.

- 3. Under the Annexure-II- 'List of Ineligible Enterprises / Industries' at **SL. 06,** the existing provision shall be replaced with the following:
  - SL. 06. "Preparation of sweets and savouries etc. excluding units using mechanized process with an investment in Plant & Machinery of more than Rs. 20 lakhs in industrially backward Districts and more than Rs. 50 Lakhs in other Districts".

4. Under Para-8 of the OFPP-2016 – 'Assistance for setting of Mega Food Park/ Sea Food Park / State Food Park', the existing provision shall be replaced with the following:

Para-8. "Financial assistance upto 20% of the Project cost (excluding cost of land) as approved by Competent Authority subject to limit of Rs.15 crore will be provided to Special Purpose Vehicle (SPV) / Implementing Agencies promoting Mega Food Park / Sea Food Park / State Food Park. These parks should have been approved under the Mega Food Park Scheme (MFPS) Scheme of Government of India or as "State Food Park" by Government of Odisha. The overall limit of such assistance from all sources shall not exceed 75% of the Project cost (excluding cost of land).

The responsibility of execution, ownership and management of the Mega Food Park / State Food Park would vest with a Special Purpose Vehicle (SPV) registered under the Companies Act/Implementing Agency. However, State Government / State Government entities / Cooperatives applying for the Project under the Policy will not be required to form a separate SPV".

5. The aforesaid amendment shall come into force with immediate effect.

**ORDER:-** Ordered that the Notification be published in an extraordinary issue of *Odisha Gazette* and copies of the Notification be forwarded to all Departments/ all Head of Department.
