

No. III-MSME-KVIB-11/2013 4337 /MSME,

In exercise of the powers conferred by section 35 of the Odisha Khadi and Village Industries Board Act, 1955 (Odisha Act 3 of 1956) and in pursuance to resolution No. 4810 dated 22.12.2011 issued by Government in Public Enterprises Department the State Government in MSME Department do hereby make the following rules further to amend the Odisha Khadi and Village Industries Board Rules, 1956, namely:-

1. (i) These rules may be called the Odisha Khadi and Village Industries Board (Amendment) Rules, 2013.
(ii) They shall be deemed to have come into force on 22.12.2011.
2. In the Odisha Khadi and Village Industries Board Rules, 1956, in rules-3, for the words "five thousand" the words "ten thousand" shall be substituted and the President, OK & VI Board is entitled to rent free residential accommodation to be provided by the Board or Rs. 7,500 /- per month towards house rent meant for category B of (b) of the aforesaid resolution.
3. Apart to above the non-official Chairman of Odisha Khadi and Village Industries Board is entitled to avail travelling allowance and medical allowance as mentioned under Point No. C & D of the aforesaid resolution i.e. TA & DA as applicable to senior class-I Officials drawing Grade Pay Rs. 8,700/- and above of the concerned Public Sector under-takings. Besides entertainment allowance and telephone facility shall be limited to the extent mentioned under Point No. F & G of the aforesaid resolution No. 4810 dated 22.12.2011 i.e. Rs. 2,500 and Rs. 5,000/- per month respectively.
4. This supersedes Industries Department Notification No. 18447 dated 06.12.2007.


