In accordance with Orissa MSME Development Policy, 2009, Para 12.1, Government in Industries Department have been pleased to decide to undertake a comprehensive district-wise drive through Directorate of Industries for identification of potentially viable sick units. Such industries shall be placed on a fast track mode for consideration of rehabilitation assistance by Government and all agencies concerned. The existing institutional mechanism of District Level Committee (DLC), Sub-Committee of State Level Inter Institutional Committee (Sub-SLIIC) and the State Level Inter Institutional Committee (SLIIC) shall be suitably reinforced for this purpose.

Ordered that the notification be published in the next issue of the extra ordinary Gazette of Orissa and copy thereof be forwarded to all Departments of Government/ All Heads of Deptts./ Accountant General (A&E), Orissa, Bhubaneswar for information and necessary action.




