In accordance with Orissa MSME Development Policy, 2009, Para 4.1 & 4.2, Government in Industries Department have been pleased decide that the infrastructural needs of MSMEs shall be addressed on priority and minimum 20% of the area in all industrial estates, industrial parks, industrial corridors and land banks shall be reserved for MSMEs unless otherwise decided by Government.

Further, IDCO shall promote new exclusive industrial parks for MSMEs at all major industrial hubs in the state such as Kalinganagar, Barbil, Jharsuguda, Sambalpur, Dhenkanal, Angul, Paradeep, Rourkela, Bargarh, Balasore, Dhamra, Gopalpur, Chhatrapur, Rayagada, Kalahandi & Choudwar and near the SEZs being set up in the State.
