In accordance with Orissa MSME Development Policy, 2009, Para 4.3, and Para 4.8 Government in Industries Department have been pleased to decide that wherever land is provided for setting up of Large & Mega Industries, 10% of the land subject to an upper limit of 200 Ac. shall be earmarked for setting up of MSMEs to facilitate setting up ancillary and downstream MSMEs preferably in a cluster mode.
