In accordance with Orissa MSME Development Policy, 2009, Para 4.7 Government in Industries Department have been pleased to decide that Common Facility Centres (CFCs) set up by Special Purpose Vehicles (SPVs) of MSME clusters shall be entitled for allotment of land on free of cost basis at locations earmarked for the purpose by IDCO.
