In accordance with Orissa MSME Development Policy, 2009, Para 6.3, Government in Industries Department have been pleased to decide that The Orissa Small Industries Corporation (OSIC) Ltd./ National Small Industries Corporation (NSIC) Ltd. may act as the Nodal Agency for sourcing and supplying of raw materials required by the MSMEs. OSIC/ NSIC shall set up Raw Material Banks to provide such support. The PSU shall accord priority in supplying raw materials to OSIC/ NSIC acting as the Nodal Agency for MSMEs and shall do so at the lowest rate as extended to any other buyer of the same material inside or outside the State.
