In accordance with Orissa MSME Development Policy, 2009, Para 7.2.e, f & g, Government in Industries Department have been pleased to decide that the local MSEs registered with respective DICs, Khadi, Village, Cottage & Handicraft Industries, OSIC & NSIC shall be exempted from payment of earnest money and shall pay 25% of the prescribed Security Deposit while participating in tenders of Government departments and Agencies under its control.

Directorate of Export Promotion & marketing will be the nodal agency for issue of detailed guidelines for implementation of the above facilities extended to local industries. Director, Export Promotion & Marketing or his nominee will be a member of the purchase committee constituted at levels above the District level in State Government Departments and agencies under the control of State Government. General manager/ Project manager, DIC or his representative will be a member of purchase committee constituted at District Level or below.

Further, to ensure that the policy on marketing support is meticulously followed, the Director EP&M or his representative shall be allowed access to tender papers, purchase documents, books of accounts etc to ascertain whether there has been any contravention in the implementation of the policy.
