ACTIVITIES OF DIRECTORATE OF INDUSTRIES DURING THE YEAR 2016-17

The Directorate of Industries, Odisha is functioning under the administrative control of newly created Micro, Small & Medium Enterprises (MSME) Department carved out from Industries Department. It is looking after promotion of MSMEs including Khadi & Village Industries, Coir Industries and Salt Industries in the State. Besides PMEGP (Prime Minister's Employment Generation Programme) is also implemented.

1. Micro, Small & Medium enterprises (MSME)

For 2016-17, against the target of 66,000 MSMEs with investment of Rs.3960.00 crore and employment of 3.30 lakh persons, 42261 MSMEs are reported to be set up with investment of Rs.1979.11 crore generating employment opportunity for 126461 persons till January, 2017.

214087 MSMEs was set up in the State with investment of Rs.10585.89 crore providing employment opportunities to 1012220 persons by end of 2015-16.

Achievement made under EIN and PC

State Government have introduced Entrepreneur Identification Number (EIN) (Intent to Establish) and Production Certificate (PC) (Intimation of Operation) during 2016-17. Online application for both has been adopted from December, 2016. Till January' 2017, 1184 EIN and 146 PC have been acknowledged by RICs / DICs.

Entrepreneur Memorandum has been discontinued & replaced by Udyog Aadhar from 18.09.2015 by Ministry of MSME, GoI. 52446 Udyog Aadhar has been acknowledged through online portal of Ministry of MSME, GoI till 25.03.2017.

i. Motivation & Training for Entrepreneurship Development

621 campaigns across State have been organized till January, 2017 to motivate 51096 youth for setting up MSMEs. 1265 youth have been provided training on Entrepreneurship Development through State support during the period.

ii. <u>Implementation of Single Window.</u>

"Odisha Industries (Facilitation) Act, 2004" has been enacted and "Orissa Industries (Facilitation) rules, 2005" has been notified. Odisha Industries (Facilitation) Amendment Rules, 2015 has been notified to streamline the functioning of Single window System. Online application through e-biz portal has been made mandatory for assistance under Single Window System during the current year.

207 proposals involving investment of Rs.524.55 crore have been accorded project level approval by District Level Single Window Clearance Authorities across the State during 2016-17 (till January, 2017).

An amount of Rs.200.00 lakhs has been provided through State Plan Scheme "Monitoring & Implementation of single window under D.I" during 2016-17 for the purpose of infrastructure development in DICs and computer and office consumables for RIC/DIC/DI.

iii. Policy support

In addition to Industrial Policy Resolution, 2015, MSME Department has announced Odisha Micro, Small & Medium Enterprises Development (MSMED) Policy, 2016; Odisha Food Processing Policy, 2016; and Odisha Startup Policy, 2016 on 24.11.2016 for promotion and development of entrepreneurial activities in the State.

During 2016-17, following incentives have been extended to eligible enterprises so far.

iv. Youth Innovation Fund.

"Odisha Youth Innovation Fund Scheme" was launched by the Hon'ble Chief Minister, Odisha on 11.08.2015 to promote innovative ideas / prototypes. 20 youth have been provided assistance of Rs.11.50 lakh during 2016-17 by Odisha Small Industries Corporation Ltd. More than 200 applications are under consideration for assistance.

v. <u>Development of Ancillary and Downstream Enterprises.</u>

To capture new opportunities and broad-basing of Industries growth around the upcoming large Industries following initiatives have been under taken during 2016-17.

- Monitoring of Plant Level Advisory Committee (PLAC) meeting for Development of Ancillary & Downstream Enterprises and store purchases by PSUs from local MSEs. Two PLACs for NALCO & NTPC convened so far.
- 2) Monitoring of Plant Level Consultative Committee (PLCC) for promotion of Ancillary & Downstream Enterprises by the Large/Mega Industries in Private Sector.
- 3) Thrust on promotion for uses of Fly Ash/Blast Furnace Slag (BFS) generated in the State & for its efficient and optimum utilization.
- 4) Organize Exposure Visit, conduct investment promotion, Road Shows, Vendor Development Programme-cum-Buyer Seller Meet, Sensitization programme for MSME etc. for promotion of Ancillary & Downstream Enterprises as well as Industrial Development of the State.
- 5) Aluminum Park at Angul; Plastic Park at Paradeep under implementation.
- 6) Land for Fly Ash Park at Angul identified & proposed to be developed through IDCO.
- 7) Survey of Ancillary Enterprises / Vendors in respect of large Industries operating in the State has been taken up.

vi. <u>Development of Food Processing Industries</u>

- Nine Food Processing Industries have been extended Capital Investment Subsidy amounting to Rs.1172.78 lakh during 2016-17 so far under Odisha Food Processing Policy, 2013.
- Operational guidelines for implementation of various provisions under Odisha Food Processing Policy, 2016 has been notified on 31.01.2017.

vii. Cluster Development Programme

Government of India schemes namely Micro & Small Enterprises Cluster Development Programme (MSE-CDP) and Scheme for Fund for Regeneration of Traditional Industries (SFURTI) are being implemented.

• Diagnostic Study for 58 Cluster completed.

- Soft interventions in 09 Clusters taken up.
- CFC in 1 cluster under MSECDP and 3 clusters under SFURTI completed.
- CFC in 3 clusters under MSECDP and 4 clusters under SFURTI under implementation.

viii. <u>Micro & Small Enterprises Facilitation Cell</u> During 2016-17, ten sitting of MSEFC was convened. 34 claim applications were received & 26 cases were disposed off till January, 2017.

ix. Udyog Samasya Samadhan Sibir

Three Udyog Samasya Samadhan Sibir has been organized at Balasore, Jeypore & Rayagada during the current year so far.

x. MSME Trade Fair, 2017 and Celebration of Entrepreneurs Week.

MSME Trade Fair, 2017 at State level and Entrepreneur's week at Distrct level are being celebrated from 5th March to 10th March. The sole purpose of such event is to disseminate different schemes/ programme implemented by govt. under MSME Sector and motivate prospective entrepreneurs for establishment of MSMEs.

2. <u>Prime Minister's employment Generation programme (PMEGP)</u> Prime Minister's Employment General Programme (PMEGP) is being implemented in the State since 2008-09 by three implementing agencies such as DIC, OK&VIB & KVIC. The achievement for Implementing Agency – DIC is as follows.

In view of this, Entrepreneur's week is being celebrated every year from 5th March to 11th March at different level like the State & District level in befitting manner .The sole purpose of such event is to disseminate different schemes/programmes implemented by Government under MSME Sector and to attend and motivate the prospective entrepreneurs for establishment of MSMEs.

(iv) <u>Testing of quality of the products manufactured by the MSEs</u>.

Before grant of Directorate of EP&M registration to the MSEs, the samples of store items manufactured by the concerned MSEs are tested in the following established six testing laboratories of the State to ascertain the quality of the store items after assuring the quality of the products manufactured by the MSEs, through periodical inspections, drawal and testing of samples. For testing of the products of Micro, Small Enterprises (MSEs), Six Testing Laboratories have been established at Cuttack, Rourkela, Angul, Berhampur, Bolangir & Balasore under the administrative control of the Directorate of Export Promotion and Marketing, Odisha, Bhubaneswar.

In order to supply quality goods to the Government Departments, Pre-delivery Inspection of the store items is being conducted by the Directorate of EP&M on payment of Pre-delivery inspection fees at the rate of 0.5% of the total order value of the store items, service tax, education cess etc. from the Government Departments / Offices subordinate to them as leviable thereon as per Central Excise Rules.

Export Promotion & Publicity-

For organization of events like Trade Fairs/Vendor Development Programme /Buyer Seller meets on IITF pattern, permanent structure of IITF model is contemplated by Government to be constructed at Bhubaneswar with all facilities to attract the National and International businessmen to the State of Odisha and engage them in State Export Business activities to a large extent. A sum of Rs.333.8700 lakh is proposed in the Annual Plan: 2017-18.

Implementation of Cement (Quality Control)-Order-2003 Government of India.

The Cement Quality Control prohibits manufacture, sale and distribution of cement in the State which does not confirm to the specified standard and do not bear the INT mark. The State Government is the appropriate authority to implement the above order. There are six Testing Laboratories under DEP&M which are located at Cuttack, Rourkela, Angul, Berhampur, Bolangir and Balasore. To provide full testing facility for cement, these laboratories need to be upgraded, modernized testing laboratories accredited because samples of cements are required to be tested. An amount of Rs.36.13 lakh is proposed in the Annual Plan: 2017-18.

Upgradation of Testing Laboratories

There are six testing laboratories under the DEP&M, Odisha which are located at Cuttack, Rourkela, Balasore, Berhampur, Bolangir and Angul to impart testing services to the Industries/MSEs and Government organizations located throughout the State. Up-gradation and Modernization of the above laboratories would help the Micro & Small Enterprises and Government organizations of the state to provide better quality products and services to the entire state by utilizing the testing services of the upgraded and modernized testing laboratories. An amount of Rs.130.00 lakh is proposed in the Annual Plan: 2017-18 and out of which flow to TSP & SCSP are Rs.20.00 lakh and Rs.17.00 lakh respectively
