NOTIFICATION

Pursuant to the provision under para 5.2.5 of the Odisha MSME Development Policy, 2022 and in supersession of this Department Notification No. 1931 dated 27.3.2017, the Plant Level Advisory Committee (PLAC) for Central Public Sector Undertakings (CPSUs) working in Odisha is hereby reconstituted with the following composition and Terms of Reference.

The Committee may co-opt any other member as special invitee.


2. Terms of Reference:

- i) Maintain database of existing ancillary and downstream industries of the CPSU concerned;
- ii) Take necessary steps to facilitate establishment of new ancillary and downstream industries;

- iii) Monitor and review the performance of the existing ancillary and downstream industries and resolve issues, if any, faced by them;
- iv) Monitor and ensure extending of mandated special benefits to Micro and Small Enterprises (MSEs) in public procurements as per provisions laid down in the Public Procurement Policy of Ministry of MSME, Government of India and Procurement Preference Policy of Government of Odisha for Micro and Small Enterprises.
- v) Monitor and ensure timely payment of dues to suppliers (Micro and Small Enterprises) of goods and services within the stipulated period of 45 days from the date of acceptance or the date of deemed acceptance of the goods or services as mandated under the MSME Development Act, 2006.
- vi) Monitor and ensure on-boarding of the CPSUs and their MSME vendors to any or all of the 3 available Trade Receivables Discounting System (TReDS) platforms as per the choice of respective CPSUs and their MSME Vendors.
- vii) CPSUs to conduct sensitization and handholding of their MSME vendors to make the MSME vendors understand the facilities available on TReDS and on-board to available TReDS platform (s) with informed choice.
- viii) The PLAC may take all steps necessary to improve quality, productivity, reduction of cost and increase in competitiveness of the ancillary and downstream industries/vendors.
- ix) The PLAC shall meet at least once in every six months.

3. Action on the decisions taken in the PLAC shall be followed up and monitored by the Collector concerned at the District Level, RDC concerned at the Divisional Level and Director of Industries (Odisha) at the state level. The G.M, DICs concerned shall furnish quarterly action taken report to the Director of Industries (Odisha) and MSME Department with the approval of respective District Collectors.




