**PT2-MSME-PSUB-ESTT-0004-2021** 3079 /MSME In exercise of the powers conferred by section 35 of the Odisha Khadi and Village Industries Board Act' 1955 (Odisha Act No.3 of 1956), the State Government do hereby make the following rules further to amend the Odisha Khadi and Village Industries Board Rules, 1956, namely:-

1. (i) These rules may be called the Odisha Khadi and Village Industries Board (Amendment) Rules, 2023.  
(ii) They shall come into force on the date of their Publication in the Odisha Gazette.
2. In the Odisha Khadi and Village Industries Board Rules 1956, in rule 12,
  - (a) for sub-rule (7), the following sub-rule shall be substituted, namely: -  
“ 7] The Secretary shall have powers to sanction expenditure of a miscellaneous or contingent nature up to an amount not exceeding ₹ 4,00,000/- (Rupees Four Lakh) in each case”;
  - (b) after sub-rule (7), the following sub-rule shall be inserted, namely: -  
“(7-A) The Secretary shall have full power in case of sanction of salary and retirement benefits of the employees”.

**ORDER:** Ordered that the Notification be published in the extra ordinary issue of the Odisha Gazette.
